4. I have agreed to sign up and be present for a minimum of 3 hours, gallery sitting.
5. For publicity purposes, I am aware that images of artworks submitted may be used online and in various media outlets, to promote the Holiday Fundraising Art Sale,
6. I understand OSA reserves the right to refuse any obscene, distasteful, or poorly presented artworks.
7. I understand that a 35% commission fee for all artworks sold will be retained as fundraising towards OSA,
8. I trust that OSA staff will do their best to inform me when my artwork has been sold, and that I am able to submit a replacement artwork of the same dimensions,
9. I have read, understand, and agree with the OSA's Holiday Fundraising Art Sale, 2023 'Submission Criteria' form.
